Our entire team was moved by Debbie's experience. Debbie lived in Ohio previously, and had access to care due to the state's expansion of Medicaid. When she moved to Georgia a few years ago, her access to care was cut off. Living with a chronic condition and uninsured, most people like Debbie are forced to use the ER for primary care. This is costly - clogging up ERs, spending more on treatment rather than prevention, and raising healthcare costs for us all. This is the opposite of a healthy care ecosystem. Fortunately, Debbie found Mosaic, where we are treating her chronic condition, providing her free medications and free mammograms, all for pennies on the dollar compared to the ER.

Our healthcare system sometimes feels incredibly complex. But at the end of the day, it is actually very simple: every community member deserves to see a doctor when they need, without bankrupting their lives.

That's why Mosaic is focused on access to care. In 2025, we continued to expand access for those in need. I'm excited for you to see what we've accomplished together. Our work saves lives and money - a successful model of community-based care for those in need.

To our supporters, we cannot thank you enough. You are the reason we are successful in this journey of caring for the uninsured together. For those who have yet to support Mosaic, or may have lost hope that changing our healthcare system is possible, I encourage you to continue reading with a renewed hope. A different healthcare system is possible, and therefore so is a better world – a world driven by people care instead of profit share. A world where all of us have simple, affordable access to care.

That was eight years ago. I joined the board a few years later, and I continue to be blown away by what Mosaic achieves.

We provide access to high quality care for people who might otherwise not be treated. Our core belief is that healthcare is a human right, and that belief drives our work. Mosaic continues to push itself to provide more care, to more people, in more ways than ever before – increased days of operation, expanding evening hours, and launching a project in community paramedicine to bring care to people where they are.

Successes



Mosaic celebrated our 10-year anniversary hosting a ribbon cutting and our first community health fair. With over 200 people in attendance, including local dignitaries such as DeKalb County CEO Lorraine Cochran-Johnson, the event honored our work in the community and launched our new brand.

In January, our organization **rebranded from Clarkston Community Health Center** to better represent visually the professional care that our patients receive each visit, to communicate our expanded geographic impact, and to show the strength of our diversity and our ability to, together, pick up the broken pieces of our healthcare system and make it better for all.

Mosaic **expanded clinic capacity by hiring a Community Health Director**, who oversees wellness programs, data systems, and quality-improvement initiatives. **We also hired a Medical Director**, who provides leadership to our team, improves the quality of our care, and serves patients - strengthening care for uninsured and underserved patients.

We hosted over 100 volunteers who provided over 5,000 hours of service, had outstanding Google reviews throughout the year, and received **80%+ satisfaction from staff, volunteers, and patients on our annual survey.**



Strategic Plan

Mosaic is in the middle of a three-year strategic plan. By the end of 2028, Mosaic aims to make Clarkston a community where everyone has access to healthcare. Our strategic plan goals are:

SERVE 3,500 INDIVIDUALS ANNUALLY

We served over 1,900 individuals with affordable and comprehensive primary and preventive care in 2025 - more than halfway to our goal.

MOVE INTO A NEW HOME IN CLARKSTON

Our organization finalized 'Vision 2028,' our plan to find a new home where we will serve as a cornerstone of a greater DeKalb Health Hub for the community.

SECURE CRITICAL PARTNERSHIPS

Mosaic built enduring partnerships with non-profits, foundations, and corporate partners, allowing us to drive improved health outcomes.

BUILD A SUSTAINABLE INSTITUTION

We are working towards a sustainable institution with an annual budget of at least \$2-\$2.5M from diverse and long-term revenue streams and robust partnerships to ensure adequate resources.

Impact

In Georgia today there are 1.2 million people without health insurance - the second-highest rate in the nation. An additional 500,000 people will lose their health insurance in the years ahead. Our work at Mosaic is more critical than ever. We work every day to expand our impact to meet this growing need and to change the course of healthcare access for the better.

Starting this year, Mosaic launched a partnership with Georgia Gateway, which now allows us to help our patients sign up for SNAP, WIC, TANF, Medicaid, and CAPS through our Wellness Center. With this partnership, we are able to impact our patients' social determinants of health - the non-medical environmental conditions that significantly influence health outcomes, risk, and quality of life. Helping our patients to access healthy food, childcare, or health insurance when they qualify will lead to better health equities in our community. We were thrilled to be able to provide 4,909 wellness program services in 2025.

He came to the United States to pursue a public health degree at Emory University, which ultimately led him to Mosaic, serving as the Director of Operations & Community Health.

Deborah Desamours, PT - Mosaic Volunteer Physical Therapist

Deborah Desamours, PT, learned about Mosaic from another Mosaic volunteer provider. Though she is retired, Deborah maintains her license to offer physical therapy treatment to our patients. Many of the patients present with knee, back, or shoulder pain frequently stemming from arthritis or injury. She starts by performing a physical evaluation to assess the problem and then develops a treatment plan to address the patient’s needs. This often includes exercises, postural correction, and patient education for injury prevention.

“I am drawn to the clinic due to the huge disparities in the healthcare system and the need for compassionate, individualized, comprehensive care for those in need,” shared Deborah. **“I don’t believe that people should suffer and go without basic healthcare because of lack of funds.”**

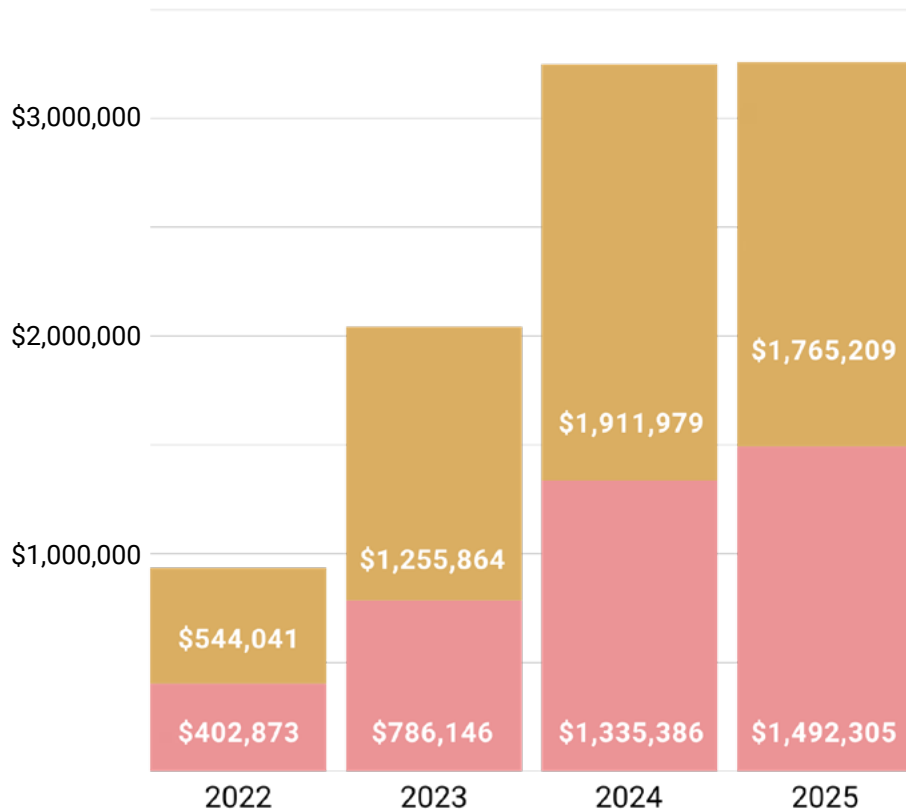
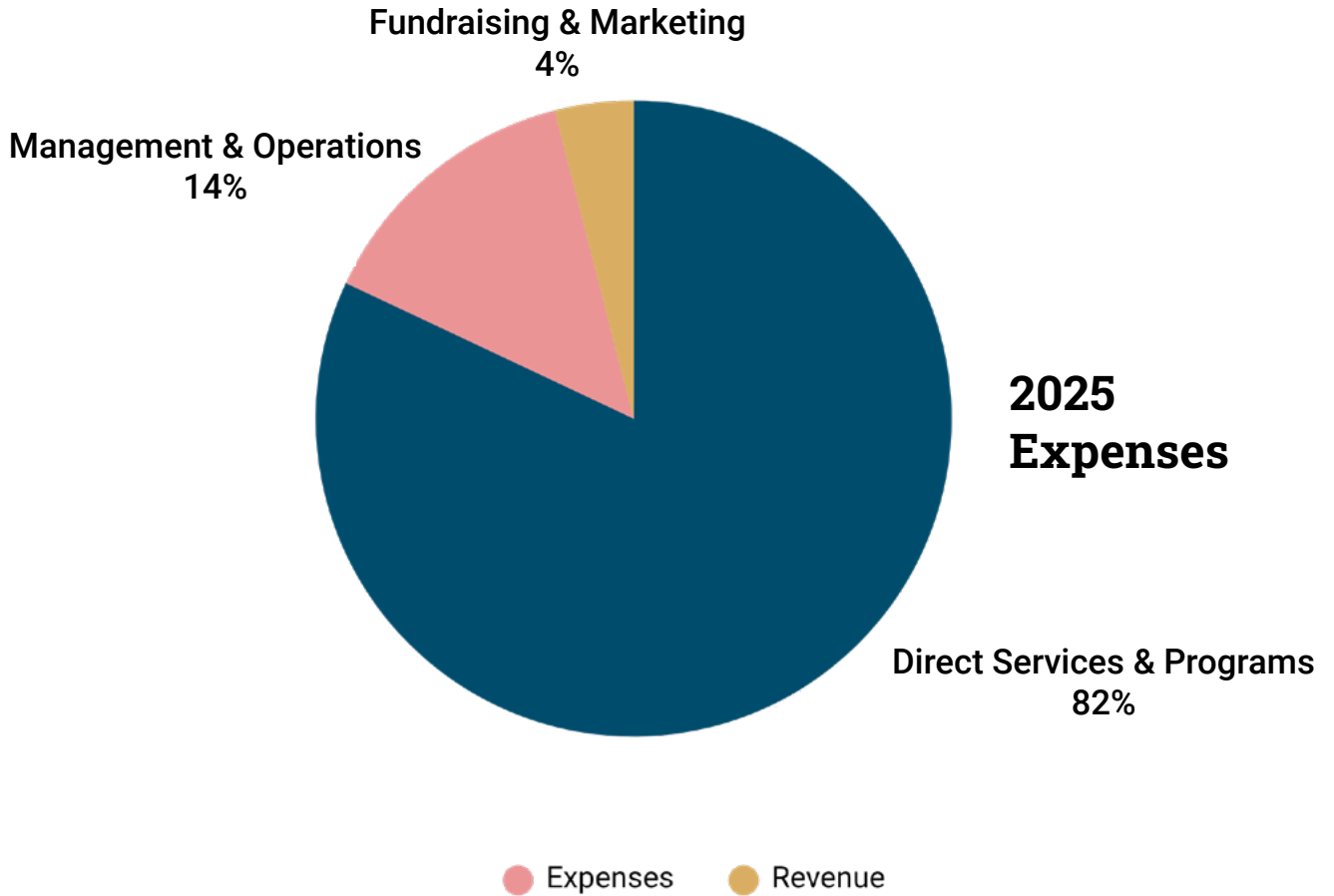

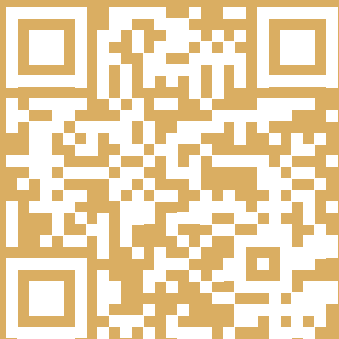
